会计的目的是通过对经济活动的记录、计量、报告,提供经济管理所需的信息,参与经济决策,提高公司的经济效益。

从某种意义上说,财务会的词语已经不是财务会计人员专用的了,应该为所有的企业管理人员和经济工作者所熟悉。

鉴于上述情况,包括会计在内的商务交流越来越多地需要用英语进行,会计英语的重要性就显得更加突出,而且会计英语的使用已不仅仅是看英文的会计报表,还需用英语就业务问题进行讨论交流。

这就要求学生不但能准确地掌握会计英语词汇的确切含义,还要熟识与会计相关业务的背景知识。

为适应形势的需要,我们编写了这本为会计人员用英语交流为主要内容的教材,供高等院校公共英语学习阶段之后的会计专业英语课程使用。

教材中既有理论的学习(如会计准则、会计账户、会计簿记、公司概况、投资证券、现金控制等),又有各种会计报表(如分录、试算表、资产负债表、损益表、现金流量表等),情景基本反映公司会计的主要业务,具有较强的实务操作性。

本书除阅读文章外,还配备了形式多样的练习,用了大量的篇幅进行会计英语的听力和会话训练,还涉及会计人员求职面试等实际,使学生犹如身临会计英语的使用环境。
