章节摘录

Criminal law refers to that body of the law that deals with conduct considered so harmful to society as a whole that it is prohibited by statute , prosecuted and punished by the government. In a criminal case , the state , through a prosecutor , initiates the suit , while in a civil case the victim brings the suit. Persons convicted of a crime may be incarcerated , fined , or both. However , persons found liable in a civil case may only have to give up property or pay money , but are not incarcerated. A "crime" is any act or omission (of an act) in violation of a public law forbidding or commanding it. Though there are some common law crimes , most crimes in the United States are established by local , state , and federal governments. Criminal laws vary significantly from state to state. There is , however , a Model Penal Code (MPC) which serves as a good starting place to gain an understanding of the basic structure of criminal liability.
