该书从中国妇女在政治、经济、家庭、健康等多方面权益的变化与发展的实践出发，反映中国妇女权益保障工作的立法、执法、守法等方面的发展状况、取得的成就、存在的问题及成因。该书介绍了《消歧公约》在中国的执行情况，并在一定程度上探究了未来中国如何实现《消歧公约》所确定的内容的对策和具体措施。

The comprehensiveness of its scale is unprecedented in the history of Women Legislation. Its establishment provided a strong legal basis for China's Women Legislation. It received wide acclaim at the Fourth U. N. World Conference on Women. Women Legislation in China has developed further upon the basis of the Law of the People's Republic of China on Safeguarding the Rights and Interests of Women. Provinces, autonomous regions, and municipalities directly under the Central Government have devised concrete measures for the implementation of this law. The new 1997 Criminal Law of the P.R.C. reinforced the protection of women's rights through criminal legislation. By adding new criminal charges, it fosters the protection of women's rights to personal freedom and dignity.
