书摘                    书摘 The reasonable person is, of course, a creature of the law's imagination. He or she is not the average or typical person, but rather an idealized image of such a person--a composite of the community's judgment as to how the typical community member ought to behave in each of the infinite variety of circumstances and activities in which there is a potential or actual risk of harm to the actor or others. The test is not what the typical respectable citizen in fact does, nor what the majority of the Community does, since the behavior (e.g. jaywalking) may fall below the community's standards of safety. On the other hand, the reasonable person is not perfect or infallible. She is permitted errors of judgment, mistakes in perception; she may even be momentarily distracted. She is human. But such errors must have been reasonable or excusable under the circumstances; they must have been consistent with the exercise of ordinary care. Attributes of the Reasonable Person. Knowledge, Experience and Perception. Tort liability for physical harm is founded upon defendant's knowledge (actual or constructive) of the risk and of some degree of probability that it will be realized (harm to the plaintiff). In negligence (as distinguished from intentional torts), the actor does not desire the injurious consequences of his conduct; he does not know that they are substantially certain to occur, nor believe that they will. There is merely a risk of such consequences sufficiently great that the ordinarily prudent person will anticipate them and guard against them. Thus, the normal actor (plaintiff or defendant) is charged with his actual knowledge and perceptions, and also with certain basic knowledge common to the community and with the ability to observe and understand his environment. Obviously, conduct must be judged in light of what the actor actually knows and observes, since the reasonable person always takes this into account. If she by chance discovers that a product has a latent dangerous defect, if she sees another vehicle approaching without lights at night, she must act accordingly, even though she would not have been negligent in failing to discover or observe these things.
