## 章节摘录

( e ) No Default , Event of Default or default under any agreement or instrument evidencing any Indebtness of the Borrower has occurred and is continuing , and no such event will occur upon the making of the Loan.

( f ) No consent or approval of , or notice to , any creditor of the Borrower is required by the terms of any agreement or instrument evidencing any Indebtedness of the Borrower for the Borrower ' s execution or delivery of , or the performance of the obligations of the Borrower under , this Agreement or the Notes or the consummation of the transactions contemplated in this Agreement , and such execution , delivery , performance and consummation will not result in any breach or violation of , or constitute a default under , the organizational documents of the Borrower , any agreement or instrument to which the Borrower is a party or any judgment , order , statute , rule or regulation applicable to the Borrower or to any of its property.

( g ) There are no actions , proceedings or claims pending or , to the knowledge of the Borrower , threatened the adverse determination of which might have a materially adverse effect on the financial condition of the Borrower or impair its ability to perform its obligations under , or affect the validity or enforceability of , this Agreement or the Notes.

( h ) Except for liens of the types referred to in the proviso in Section 10.6 , the Borrower has good title to its property free and clear of all liens or other encumbrances securing Indebtedness , and its obligations under this Agreement rank , and its obligations under the Notes will rank , at least pari passu with all its other Indebtedness.

( i ) The Borrower ' s audited financial statements as at December 31 , 1998 and for the fiscal year ended on that date as heretofore delivered to the Bank are completed and correct , have been prepared in accordance with generally accepted principles of good accounting practice in the Republic of Somewhere and have been certified by a firm of independent accountants as fairly presenting the financial condition of the Borrower as at that date and the results of its operations for that fiscal year.

( j ) There has been no material adverse change since December 31 , 1998 in the financial condition of the Borrower or in the Borrower ' s ability to perform its obligations under this Agreement or the Notes.

( k ) None of the transactions contemplated in this Agreement ( including , without limitation , the borrowing hereunder and the use of the proceeds thereof ) will violate or result in a violation of Section 7 Of the Securities Exchange Act of 1934 , as amended ( or any regulations issued pursuant thereto , including , without limitation , Regulations G , T , U and X of the Board of Governors of the Federal Reserve System , 12 C.F.R. , Chapter II , as amended ) .

( l ) The execution and delivery of this Agreement and the Notes are not subject to any tax , fee or other charge , including , without limitation , any registration or transfer tax , stamp duty or similar levy , imposed by or within the Republic of Somewhere or any political subdivision or taxing authority thereof or therein. ....
