前言

"上外-朗文学生系列读物"是专门为学生编写的一套阅读理解教学参考图书。

内容循序渐进,适合中学与大学不同年级的学生及不同程度的英语自学者,其目的在于帮助读者提高 英语阅读理解能力,增加词汇量及增进对英语语法和句型的认识。

每册的课文都是一些妙趣横生的故事和西方家喻户晓的笑话。

通过阅读,读者还能增进对西方幽默感的理解。

每篇故事后附有六、七项练习,所用的词汇大都可以在课文中找到,一方面方便读者理解题目, 另一方面令所学过的词汇在各课不断重现,使学生加深印象。

绦习主要包括两大类型: (1)在英语考试中常见的练习,如多项选择题,正误题等。

(2)专门针对中国学生在英语学习中的难点而编写的练习,例如辨别不同的词类、如何正确选用介词、为单词或习语寻找同义词或反义词等。

以下概括地介绍这套丛书的各类练习题及它们在教学上的主要作用。

多项选择题: 多项选择题是英语测试中经常出现的题型之一。

这套丛书中每个故事后所附的第一个练习就是多项选择题。

初级读物(A)的多项选择题由四小题组成,每题有四种选择;中级读物(B)也是由四小题组成,但 每题有五种选择;而高级读物(C)则由五小题组成,每题四种选择。

这样安排的目的是随着程度的加深,对读者的选择能力有进一步的要求。

正误题: 正误题也是一般英语测试中常见的题型,因此本套丛书中大部分课文后都编排了这种题目,特别在A级和B级读物中。

在句子中删除或加进一两个字,往往会使句子的含义完全改观。

这类练习不但测试学生对课文内容的理解力,也测试他们对句型的认识。
